CALL TO ORDER

Meeting was called to order by secretary, Jaqueline Dedeaux at 10:04 a.m.

APPROVAL OF MINUTES

Marijuana and Teenagers: Is That the Weed Talking?

This course is designed for those who work with adolescents who may be using marijuana. The public has been told repeatedly over the past two decades that marijuana use is basically harmless. However, an accumulating body of new research suggests there are risks especially potent for teenage or younger marijuana users, affecting how they think, feel, or behave. Problem behaviors can appear, in fact may be even more likely to appear, when the person is not "high" but in rebound from use or because of lingering cognitive or emotional effects. Sometimes what may be viewed as a "problem" kid can be the result of marijuana use. This course will discuss the research on some particular risks, their relevance in clinical or justice settings, and ways of responding that might help both the practitioner and the client.

Objectives – Participants will:

1. Investigate the research on some risks and the problematic behaviors they may produce.
2. Identify skills that can help address youth exhibiting these behaviors and work toward positive resolutions for both the immediate and more long-term outcomes.

Rationale: Research is often ahead of what the general public commonly knows. Despite a public campaign that minimizes the risk of marijuana use, there is now a body of research suggesting that some behaviors we see in youth such as disorganized thinking or aggressive behavior, can be made worse by either the presence of marijuana, withdrawal from its use, or long-term effects from ongoing use. A person does not have to be "high" to be having a marijuana-related problem. This session will review some of the latest research on those outcomes and then turn toward practical ways to deal with adolescents who may be exhibiting these effects.
