COMMITTEE UPDATES:

<u>GRANTS COMMITTEE</u>: Gloria reported six applications. Gloria thanked Sharon for her awesome work working with each grantee to get their information updated and request additions. Once the updates are completed, we will have all of the FY21 grant money expended. FY22 RFP is coming out shortly.

<u>ANNUAL REPORT</u>: Willie reported that the annual report will be finished soon. It is finished and needs to be printed.

<u>LEGISLATIVE COMMITTEE</u>: Toni Kersh announced that this legislative session focused more on the foster care side. There was some talk about Referees (appointed by Chancellor) vs. Youth Court Judge (County Court position) and having all youth courts be under a Youth Court Judge. AOP funding was asked for and denied. This session the plan is to ask for three pilot sites instead of full state. Tashia announced that this session the definition of neglected child has been changed in statute and now CPS will be represented in youth court processes. Definition of reasonable efforts has also been changed.
