Specialist's Update: FY 2023 Title II Formula Grant application due in JustGrants on 08/21/2024. Currently in Year 3 of the FY2021-2023 Three-year plan and therefore will be submitting no changes and/or updates to current plan in place.

Preparing budgets for recommended applicants for the FY2020 Title II Formula Grant funds to Oktibbeha County Youth Court and Wayne County Youth Court for a projected start date of September 1, 2023, through August 31, 2024.

Project period extension approved for FY 2019 through 09/30/2024 with the intent to award a second year for the Too Good for Violence Project to the BGCCM.

Ms. Holmes announced that she will be retiring at the end of December, 2023. Dr. Martin thanked Ms. Holmes for her years of service to the State Advisory Group and the State of Mississippi.

New business: Interest of Justice Issue.

Dr. Martin asked that the grants committee look into having an Electronic application for grants in 2024 to make applying for our grants easier for the small groups that will need to apply.
